ATTENTION: LESS THAN TWO WEEKS UNTIL ICD-10 COMPLIANCE RULES GO INTO EFFECT!

Starting October 1, 2015, New York State Medicaid will begin accepting and processing claims using ICD-10 diagnosis and procedure codes.

Top 10 things all providers should know:

1. **Claims for Dates of Service on and after 10/1/2015 require valid ICD-10 Codes:** Claims with ICD-9 codes for dates of services on and after October 1 will be rejected by pre-adjudication edits.
2. While ICD-9 and ICD-10 codes are not allowed within the same claim, ICD-9 claims and ICD-10 claims can be sent in the same file.
3. Providers currently submitting ICD-9 primary diagnosis code **7999** - "Other Unspecified Diagnosis" are recommended to use ICD-10 code **R69** – "Illness, unspecified".
4. **ePACES ICD Version radio button:** Starting October 1, you must select which ICD code version is submitted on your claims. This field currently defaults to ICD-9. See the [ePACES Claim Quick Reference Guides](#) for more information.
5. "I'm a _____ provider type, does ICD-10 really impact me?" Review the [FAQs](#) to see how your NY Medicaid claims will need to be submitted.
6. **eMedNY will not publish an ICD-9 to ICD-10 crosswalk.** Use the extensive resources at <https://www.emedny.org/icd> to explore ICD-10 coding and train your office.
7. **Electronic Claims Submitters:** Make sure your

software submits the appropriate Code List Qualifier designating either ICD-9 or ICD-10 diagnosis codes are on the claim. Principal diagnosis is required on all electronic claims.

8. **Providers using Vendors, Clearing Houses and Service Bureaus:** Communicate with your vendors to understand what you may need to do in order to be ready on October 1 and coordinate testing in eMedNY's Provider Test Environment.
9. **The Provider Testing Environment:** Electronic claim submitters and vendors are able to test ICD-10 claim submissions and receive paper or PDF remittance advices from eMedNY right now. Detailed instructions on testing can be found at https://www.emedny.org/Notice/ICD_10_7-8-14.pdf.
