Introduction

- The new Enteral Authorization web-based portal will be available soon for use by New York State Medicaid providers.
- The portal is a user-friendly application for requesting and activating enteral prior authorizations in real-time.
- The Medicaid Interactive Voice Response System (IVR) will remain available. The IVR and Web Portal may be used interchangeably.
- No changes are being made to Medicaid Enteral coverage criteria.

DMEPOS Manual

- Enteral Therapy information can be found in Section 4.2 of the Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS) Manual.
- Enteral formulas require prior authorization via the Portal or Interactive Voice Response (IVR) System.
- Procedure codes requiring prior authorization via the Portal or IVR are identified by the asterisk (*) next to the procedure code's description in the manual.
- The ordering provider must request the prior authorization and place the prior authorization number on the fiscal order. The dispensing provider must activate the prior authorization by verifying and submitting the enteral procedure code.

Enteral Formula Coverage Criteria

- Members who are **fed via** nasogastric, gastrostomy or jejunostomy **tube**.
- Members with **inborn metabolic disorders**.
- **Children up to 21 years of age**, who require liquid oral nutritional therapy when there is a documented diagnostic condition where caloric and dietary nutrients from food cannot be absorbed or metabolized.
- Adults with a diagnosis of HIV infection, AIDS, or HIV-related illness, or other disease or condition, who are oral-fed, **and who...**

Enteral Formula Coverage Criteria Continued

1. require supplemental nutrition, demonstrate documented compliance with an appropriate medical and nutritional plan of care, and have a body mass index (BMI) under 18.5 as defined by the Centers for Disease Control, up to 1,000 calories per day; **or**
2. require supplemental nutrition, demonstrate documented compliance with an appropriate medical and nutritional plan of care, have a body mass index (BMI) under 22 as defined by the Centers for Disease Control, and a documented, unintentional weight loss of 5 percent or more within the previous 6-month period, up to 1,000 calories per day; **or**
3. require total oral nutritional support, have a permanent structural limitation that prevents the chewing of food, and placement of a feeding tube is medically contraindicated.

Enteral Formula Authorizations – Prescribers

- Prescribing provider will access the Portal or IVR System to request prior authorization for enteral nutritional formula.
- Provider will be required to answer member specific questions regarding medical criteria.
- If criteria are met, the provider will receive a prior authorization number.
- The authorization number is written or transferred to the fiscal order and shared with the dispensing provider.
- Filling out the Prescriber Worksheet in advance helps gather the necessary information. The link to the worksheet is included on the Resource slide at the end of this presentation.

Enteral Formula Authorizations - Dispenser

- Dispensing provider (Pharmacy, Medical Supply Dealer, DMEPOS Supplier) will use the Portal or IVR to access and activate the prior authorization.
- Once accessed, the dispensing provider enters the HCPCS code that matches the formula found on the fiscal order.
- If the code matches the information entered, the authorization will be activated and available for claims processing.
- Filling out the Dispenser Worksheet in advance helps gather the necessary information. The link to the worksheet is included on the Resource slide at the end of this presentation.

Automated Enteral Authorization is Not Available When:

- The member requires more calories per day than policy will allow.
- An oral fed adult requiring supplemental nutrition with a BMI between 18.5 and 21.9 (up to 1,000 calories/day).
- An oral fed adult with a BMI under 18.5 who requires a 3rd authorization within a 365-day period.
- An adult with a permanent structural limitation.
- A new provider must dispense the product.

These requests should be submitted using Prior Approval Request Form (eMedNY 361502) or ePACES with uploaded documents for review. Please include medical justification with the prior approval submission.

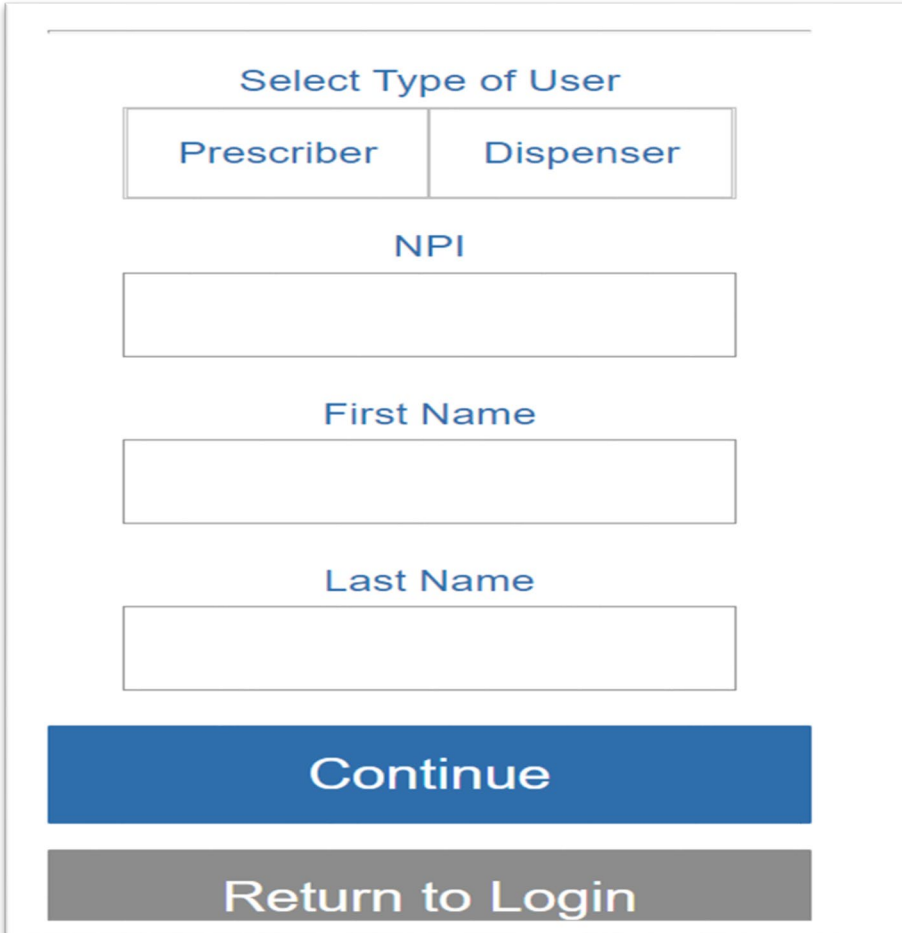

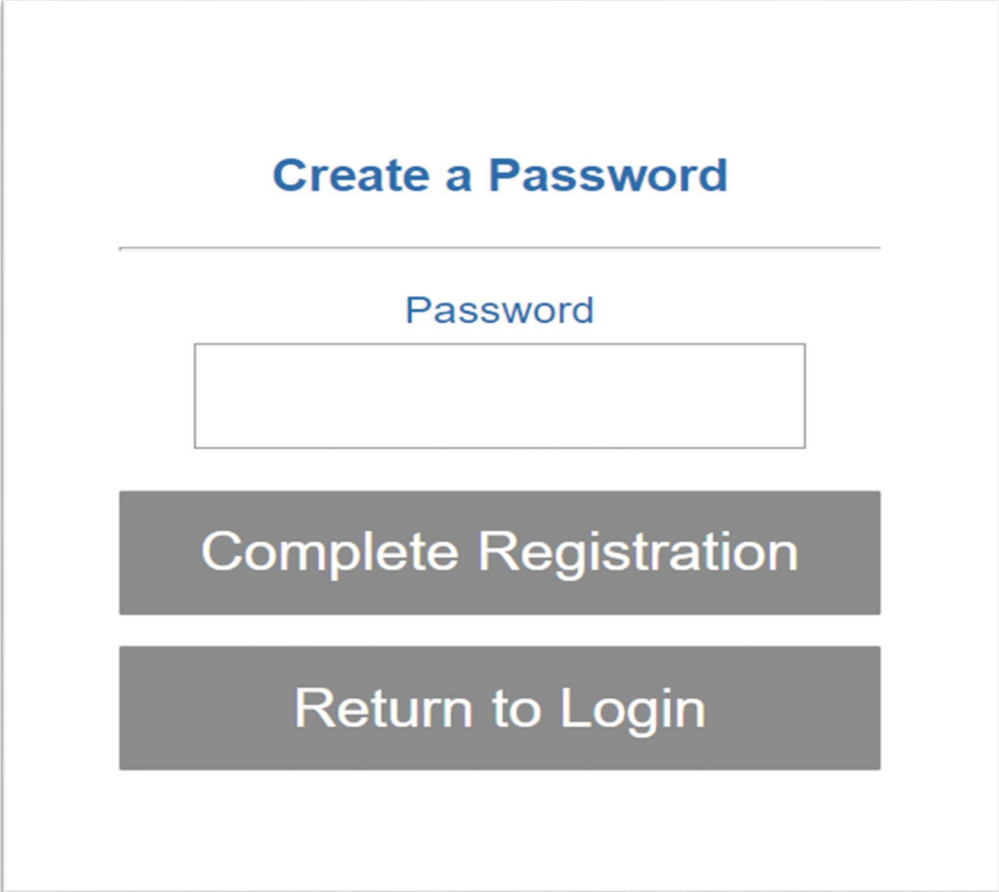

Creating a Portal Account

- Create a Password
(must be at least 14 characters long and contain at least one letter, one number, and one special character)
- Click on Complete Registration

Creating a Portal Account - Tips

- Only one account can be set up per NPI number.
- Prescriber's NPI refers to the Ordering Provider. Dispenser's NPI refers to the Pharmacy or DME supplier.
- Only one email and phone number can be associated with an NPI number for multi-factor authentication login.
- After initial account set up, logging in will require an email and password.
- A confirmation code may be received via email or text.
- Dispensing providers will be asked for their Category of Service when registering.

Requesting a Prior Authorization - Prescriber

For example: Malnutrition documented by serum protein levels, albumin levels or hemoglobin, changes in skin or bones, or physiological disorders resulting from surgery.

Medicaid Enteral Formula Coverage Criteria

View Medicaid Enteral Formula Coverage Criteria

- Medicaid covers enteral nutritional therapy when it is an essential component of a medical treatment plan ordered by a prescriber

Medicaid Enteral Coverage Criteria

Enteral nutritional therapy is only covered by Medicaid as an integral component of a documented medical treatment plan ordered in writing by an authorized prescriber. There must be a documented diagnosis showing that caloric and dietary nutrients from food cannot be absorbed or metabolized. This must be substantiated in the patient's medical record by documented physical findings or laboratory data.

Enteral nutritional therapy is not covered as a supplement of daily protein-caloric intake when there is not documented medical necessity or as a convenient food substitute.

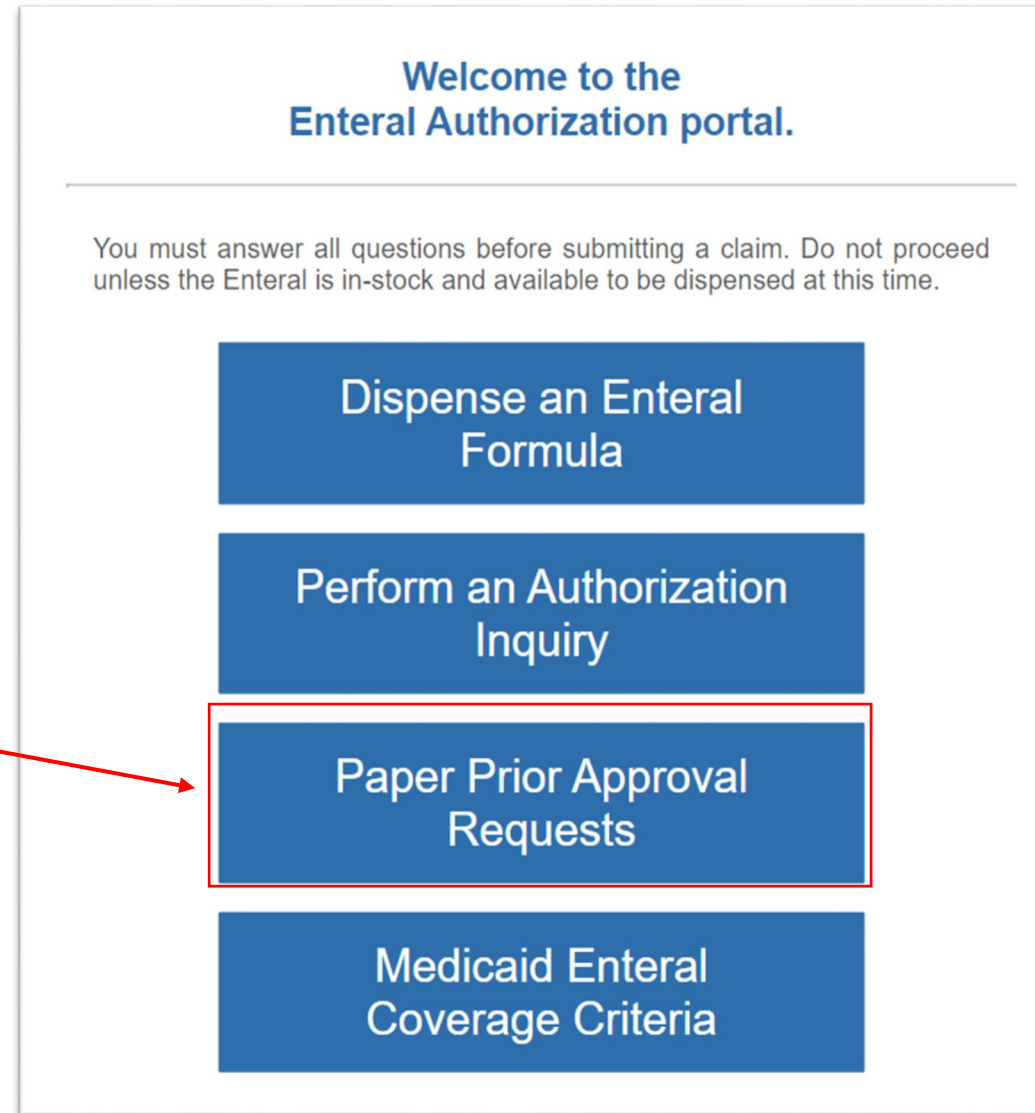

The Prescribing Provider must sign the form in the signature field of Section 1 except in the following circumstance: If the Prescribing Provider has written a fiscal order to be used in lieu of signing the eMedNY 361502, the Dispensing Provider must write "Appears on Order" in the prescriber's signature field in Section 1 of the form.

The pharmacy or DME provider must complete Section 2 and send it to: eMedNY, PO Box 4600, Rensselaer, NY 12144-4600.

- **What are the benefits of using the Portal for Enteral Formula Prior Authorization?** The Portal will allow users another option to the IVR for enteral prior authorization requests.
- **Have any changes been made to the IVR Enteral Prior Authorization Number?** No, the IVR Enteral Prior Authorization call number remains the same at (866) 211-1736.
- **If providers have an ePACES account, are they already set up to login to the Portal?** No. The Portal is a separate sign in screen with different credentials. Users must create a new account, user ID and password to use the Portal.
- **Will paper prior approval request forms still be available?** Yes. Paper prior approval request forms are still available. Please use eMedNY.org website and use second tab labeled Information, click on eMedNY Paper Forms then Order/Prior Approval Request-Pharmacy/DME, Nursing, Eye Care, Physician.
