## REMINDER: DME PROVIDERS PHARMACISTS AND PRESCRIBERS

## Approximately 1.5 million beneficiaries continue to access prescription and/or supply benefits through the Medicaid FFS program

While pharmacy benefits for the majority of Medicaid beneficiaries were bundled into managed care effective October 1, 2011, *approximately 1.5 million beneficiaries continue to access drug and supply benefits through the Medicaid FFS program.*Beneficiaries that are not currently enrolled in a mainstream managed care plan will continue to obtain these benefits from Medicaid until such time that they are moved into managed care or care management. In addition, for dual eligible beneficiaries enrolled in both Medicaid and Medicare Part D plans, Medicaid will reimburse only for eligible drugs in classes excluded by Medicare.

**Supplies** (medical/surgical) are items other than drugs, prosthetic or orthotic appliances, or Durable Medical Equipment (DME), which are ordered by a qualified practitioner in the treatment of specific medical conditions and which are: consumable, non-reusable, disposable, or for a specific rather than incidental purpose, and generally have no salvageable value (e.g. gauze pads, bandages, diapers etc...). **Supplies** (medical/surgical) include all items listed in 4.1 through 4.3 sections of the DME Procedure Code Manual available at:
