Dear Medicaid Transportation Vendors:

This letter is an update from my October 31, 2011 communication.

The Department of Health (DOH) is pleased to announce that, pursuant to Governor Andrew M. Cuomo's Medicaid Redesign Team initiative, the Medicaid program will cover **transportation of all Medicaid enrollees under the fee-for-service program** for enrollees of several counties, as depicted in the table below.

Some of you transport enrollees whose managed care (MC) plans included emergency and/or non-emergency transportation as a covered benefit. For dates of service on or after the transition date identified in the table, the MC plans in the counties above will no longer authorize or reimburse enrollee transportation. Rather, as of the transition date, all non-emergency transportation must be requested through and secured by Medical Answering Services (MAS) through the same mechanisms currently used by MAS.

Emergency transportation is to be billed directly to eMedNY as applicable. Accordingly, as of the transition date, for all trips performed on behalf of the Medicaid program, transportation

vendors will be reimbursed via eMedNY at the established fee-for-service fees for the enrollee's county of fiscal responsibility.

## Trips with Dates of Service prior to Transition Date Assigned by MC Plans

For trips with dates of service prior to the transition date, the MC plan remains responsible for trip reimbursement. MAS will not accept requests for reimbursement of trips with dates of service prior to the transition date.

## Trips with Dates of Service after Transition Date Assigned by MC Plans

MC plans may have scheduled enrollee's non-emergency trips for dates of service beyond the transition date, pursuant to their existing methodology and responsibility. We will honor these trips.

The table below illustrates the date by which information regarding trips assigned to you by MC plans must be sent to MAS. After the identified date, the trips will not be accepted.
