Survey of MCO Outreach Efforts – Mainstream Medicaid Managed Care

- Surveys were distributed to Managed Care PNDS contacts on October 25th. MCOs were directed to cease all outreach efforts until survey is completed and DOH informs MCO it may resume provider enrollment outreach.
- Based on survey responses, 10 mainstream MCO's have been approved to resume with provider enrollment outreach.
- 3 mainstream MCO's are in the process of finalizing their outreach letters to providers that should not have been contacted.
- 4 mainstream MCO's have not responded to DOH's November 8th communication that provided our survey review findings.
- DOH will continue to outreach with the 7 remaining mainstream plans.
- Beginning on 11/21, an updated active list of Medicaid FFS providers will be sent to those MCOs approved to continue outreach efforts (will include supervising pharmacists)

Survey of MCO Outreach Efforts – Medicaid Managed Long Term Care

- Surveys were distributed to Managed Care PNDS contacts on October 25th.

Enrollments

- Over the past month, the average number of new applications received weekly have increased by:
 - 84% Billing
 - 458% Non-billing (OPRA)
- Currently there are 13,000 enrollments/maintenance transactions pending DOH decision including those awaiting additional information from the provider
- On average, DOH processes 1,400 enrollments/maintenance transactions each week





Enrollments (cont'd)

- New enrollments must be completed, with receipt of all necessary documentation, within 90 days otherwise the application is automatically withdrawn.
 - Exception: If Medicare enrollment is needed, then additional 30 days is given
- DOH is working with CSRA to provide MCOs with a list of enrollments being tracked
 - Enrollment tracking number (ETN)
 - NPI number where available
 - Provider name
 - Status



Medicare Enrollment

- The following network provider types, who previously opted out of Medicare, must include the documentation they received from Medicare stating that they cannot apply for two years
 - Clinical social worker
 - Podiatrists
 - Chiropractors
 - Physical therapists



Behavioral Health

- DOH provided a presentation to Behavioral Health providers on 11/8/2017
- Examples of Medicaid enrollment requirements for BH provider types:

PROVIDER TYPE	ENROLLMENT REQUIREMENT
Licensed Mental Health Counselor	Not required to enroll
Licensed Marriage Family Therapist	Not required to enroll
CSW (Clinical Social Worker)	Required to enroll (required to enroll in Medicare prior to Medicaid)
Applied Behavioral Analyst	Not required to enroll
Adult Home And Community Based Services OMH	Not required to enroll
Children's Home and Community Based Services OMH	Required to enroll
LMSW (Licensed Master Social Worker)	Not required to enroll

- Enforcement of Enrollment Requirement
 - DOH is in the process of obtaining, from CMS, the enforcement date for the Medicaid enrollment requirement
 - MCOs should not begin to terminate network providers until DOH provides guidance on the enforcement date



FAQs: Do they need to enroll?

Provider	Enrollment Requirement
Out of state, in-network providers	Required to enroll
Out of state, out-of-network providers	Guidance will be provided in the future
In-network pharmacies, including out of state	Required to enroll
Out-of-network emergency providers	Guidance will be provided in the future
Private Duty Nurses (LPN/RN)	Required to enroll
Non-Emergency Transportation	Required to enroll
