Immediate Obstetric Billing Changes for Prenatal Services Related to Upcoming Global Obstetric Fee Changes

Effective immediately, New York State Medicaid fee-for-service (FFS) directs all Medicaid-enrolled providers of antepartum, postpartum, labor and delivery services to use the below for services provided to individuals that initiate prenatal care on or after June 1, 2026, and/or have an estimated due date on or after January 1, 2027:

- Evaluation and Management (E/M) Common Procedure Terminology (CPT) codes with a -TH modifier;
- Pregnancy-related O or Z ICD-10 diagnostic codes for all prenatal visits; and
- Initial prenatal visits must include the Category II CPT code 0500F.

For services provided to Medicaid members who have established prenatal care prior to June 1, 2026, current billing guidance applies through December 31, 2026.

E/M CPT codes are to be used for prenatal services in place of global/bundled obstetric CPT codes (noted in table below) in anticipation of January 1, 2027 comprehensive changes to obstetric-related services per the American Medical Association. Bundled/Global CPT codes that will be deleted and **unavailable when service dates include dates on or after January 1, 2027:**

As of January 1, 2027, additional CPT codes used for billing obstetric services will be revised and deleted. Further guidance will be released by the American Medical Association for obstetric-related services, and the Department will release further updates.
