

NYRx Electronic Prior Authorization via CoverMyMeds: Effective July 15, 2025

Electronic Prior Authorization Submission

Starting today, **July 15, 2025**, NYRx, the Medicaid Pharmacy Program, accepts electronic prior authorization (ePA) requests via CoverMyMeds[®] in addition to the current phone and fax submission methods. Prescribers should consider this alternative option as an effective and efficient way to request a PA other than by phone or by fax.

CoverMyMeds streamlines the prior authorization process by guiding prescribers through required clinical questions, which can lead to real-time approval when clinical criteria are met.

Through this platform, prescribers are able to:

- Submit prior authorizations electronically, with the opportunity for real-time approval if clinical criteria are met.
- Upload necessary supporting documentation.
- Track request status in real-time.

Additionally, pharmacy providers who utilize CoverMyMeds have the opportunity to initiate medication ePA requests on behalf of the member for completion by the prescriber. CoverMyMeds directs the case to the prescriber's queue and prompts them to complete and submit the ePA to NYRx.

What Pharmacy Providers and Prescribers Need to Do
